The meeting was called to order by the President. The Directors were informed that in order for the corporation to maintain entertainment in accordance with the law, new entertainment licenses were necessary.

Upon Motion duly made and seconded, it was unanimously voted that _____ is hereby appointed Manager of its entertainment business with as full authority and control of the premises described in the license and licenses application of the corporation and of the conduct of all business therein relative to the maintenance of entertainment as the license itself could in anyway have and exercise if it were a natural person and resident of the Commonwealth of Massachusetts, for the year beginning January 1, 2009 and continuing thereafter in effect until the Licensing Board in writing acknowledges receipt of a written request for a Change in Manager, that a copy of this vote, duly certified by the Clerk of the corporation and delivered to said manager or principal representative shall constitute the written authority required by law and that a certified duplicate copy of said vote be filed with the Licensing Board.

Voted: The said Manager on behalf of the corporation be and hereby is instructed to apply for new license to maintain entertainment by the corporation on the premises at _____ in the said Town of Middleton, Massachusetts.

And Voted: That said Manager _____ on behalf of the corporation, is further authorized to sign the necessary papers to comply with the requirements that are necessary to carry this out in full effect, and that this authority includes the power on behalf of the corporation to make oral and written statements generally, to make oral and written statements under the penalties of perjury, to answer questions generally, and to answer questions under the penalties of perjury.

There being no further business to come before the meeting, it was voted to adjourn.
